# It's a Movement, Not a Moment Racial Justice Team Update from Nancy Reyes, Chair

Two significant Civil Rights leaders passed away this month. Both Rev. C.T. Vivian and Rep. John Lewis have been active in the fight for racial justice for decades, working closely with Martin Luther King, Jr. While Rev. Vivian worked on a more local level, organizing efforts in Nashville, he also counseled four presidents on Civil Rights issues. Rep. John Lewis became the conscience of the Congress after he was elected to work at the national level.

In Central NJ, there have been fewer protests this past month, but there is still a lot going on in the movement to bring racial justice into every aspect of our lives. We pray for the safety of those living amidst violence, and for those in authority to have the wisdom and resources needed to address concerns as well as provide safety and security. Knowing that some feel violence is an appropriate reaction to their frustration, we pray that God's leaders will be able to reach them before more are hurt and more property destroyed. By far, the majority of Americans and even those in *Black Lives Matter* and other organizations leading the movement have remained peaceful and are working for systemic change that is really necessary.

Yes, people are tired of hearing about injustice in the news, but imagine how tired people of color who fought for these same necessary changes identified even by our government studies over fifty years ago feel. A few laws were enacted then but those passed weren't enforced properly with subsequent revisions watering them down. That's why this work requires an ongoing movement, with sustained pressure to pass thoughtfully worded legislation with accountability as part of any new policies or reorganization. Citizens must be educated about the issues and aware of what is really being done without losing stamina and moving on.

That's why Prince of Peace's Racial Justice Team decided our focus for now will be on education, educating ourselves and educating our members about the history that led to our current laws and social structures based on white supremacy so well hidden that most didn't realize it. We're working to learn the truth so we are not blindly complicit in systemic racism.

## WHAM's Statement on the Recent Killings of African Americans

The recent killings of George Floyd, Rayshard Brooks, Ahmaud Arbery, Breonna Taylor, Nina Pop, Tony McDade, David McAtee, and many others once again bring into focus the deadly racism that festers in the heart of American history, economy, and communities. We, as the religious leaders of Windsor Hightstown Area Ministerium (WHAM) in Central New Jersey, stand in solidarity to affirm that Black Lives Matter and that the concepts of white supremacy and white normativity are evil and must be resisted in our communities. All life is sacred, and as such we must acknowledge, condemn, and eradicate the violence — both historical and everyday perpetrated towards our siblings of color. Together, we seek healing for the harm that has been done.

Guided by our various faith traditions and convictions, we as religious leaders affirm that we can and must band together amidst our diversity and reaffirm our commitment to each others' equal rights with dignity. We call upon all community members to commit ourselves to seeking justice, working toward dismantling racist systems, and building a future America and world where peace is an active and present reality. The road ahead is difficult and confronting, but we have faith that together we can and will achieve a community where all are welcome and live in peace.

The leaders who make up WHAM have each collected resources relevant to specific faith traditions that can help shape our response to these events. Please contact us if you would like assistance.

### The One-in-a Million Boy by Monica Wood



# Food, Clothing, Empty Bags, Monetary Donations Still Needed by St. Bartholomew's

Our partner in ministry, St. Bartholomew's, is very busy this summer supplying much-needed food and clothing to their neighbors. Prince of Peace, along with our scout troop, continues to be a major supplier of the food needed. All donations are much appreciated, and can be placed in the bins outside the community room entrance (white doors) at any time. The bins are emptied frequently.

Produce from the Peace Garden is also taken to St. Bart's on Wednesdays and is distributed at the same time as lunches are picked up by community folks who need them. Thank you to the gardeners who maintain the Peace Garden and harvest the vegetables and herbs, and who also provided 80 bag lunches one week.

Monetary donations are also welcome. Checks may be written to Prince of Peace and noted for St. Bart's.

In addition to the Food Pantry, St. Bart's has opened a Clothes Closet for the community, which has proved to be fulfilling another need. Currently, the Clothes Closet is very low on clothing and is in need of any kind that can be donated. They can also use bedding, blankets, towels, and the like. Bags of these items, too, may be left in the bins outside the white doors.

Since we will not be able to have a Rescue Mission Clothing Drive this fall, St. Bart's is a perfect alternative. And, there is a need for empty grocery bags to package the food and clothing items. These may be left in the bins outside the white doors, as well.

Dear Prince of Peace Family,

Several of us have been members of various units of the Boy Scouts of America (BSA), in the past, or currently. It is a heartbreaking fact that at times, predators have used this organization to sexually abuse others. PoP has been asked to share the notice [on page 7] from the BSA national office. BSA is attempting to reach all those who wish to make a claim. Further information is available at www.OfficialBSAclaims.com or 1-866-907-2721.

BSA has continually increased efforts, over decades, to protect our youth. Our current protocols are stronger than those of many youth-serving organizations. I remain involved with Pack 48, and with our Mercer Area District as well, to see that we continue to follow our training. I am here to discuss any concerns or questions you might have.

On a personal note, if you are searching for support, our pastors are a resource for us all. Confronting abuse, even after decades, can be a difficult struggle. I am most sorrowful and enraged that some have used important, supportive organizations such as churches and the BSA to harm others.

Dear Prince of Peace Lutheran Church:

As you may be aware, the national organization of the Boy Scouts of America has filed for Chapter 11 bankruptcy in order to restructure its nonprofit organization and pay Sexual Abuse Survivors who were abused during their time in Scouting. Sexual Abuse Survivors include anyone who was sexually abused during their time in Scouting on or before February 19, 2020. We are requesting your assistance in notifying anyone you are in contact with who may have been involved with Boy Scouts, Cub Scouts, or any entity or activity associated with Scouting.

You will find a short one-page notice [on page 7], which provides additional information about the bankruptcy case and the deadline to file claims by November 16, 2020. You can also obtain further information and materials by visiting www.OfficialBSAclaims.com or calling 1-866-907-2721.

# Sexual Abuse Claims in Boy Scouts Bankruptcy

Regardless of how old you are today or when the sexual abuse occurred, you need to file your claim by 5 p.m. (Eastern Time) on November 16, 2020.

The Boy Scouts of America ("BSA") has filed bankruptcy in order to restructure its nonprofit organization and pay Sexual Abuse Survivors. Please read this notice carefully as it may impact your rights against BSA, BSA Local Councils and organizations that sponsored your troop or pack and provides information about the case, In re Boy Scouts of America and Delaware BSA, LLC, No. 20-10343 (Bankr. D. Del.). This notice is a short summary. For more detail, visit www.OfficialBSAClaims.com or call 1-866-907-2721.

#### Who Should File a Sexual Abuse Claim?

Anyone who was sexually abused during their time in Scouting, on or before February 18, 2020, must file a claim. This includes sexual abuse in connection with Boy Scouts, Cub Scouts, or any entity or activity associated with Scouting. Sexual Abuse Claims include, but are not limited to: sexual misconduct, exploitation, or touching, sexual comments about a person or other behaviors that led to abuse, even if the behavior was not sexual or against the law, and regardless of whether you thought the behavior was sexual abuse or not. These acts could be between a: (1) child and an adult or (2) child and another child.

### When and How Should I File a Sexual Abuse Claim?

You should file a claim using the Sexual Abuse Survivor Proof of Claim by November 16, 2020 at 5:00 p.m. (Eastern Time). If you do not file a timely Sexual Abuse Claim, you may lose rights against BSA, BSA Local Councils or organizations that sponsored your troop or pack, including any right to compensation. Only BSA is in bankruptcy. If you have a claim against the BSA Local Councils or other organizations, you must take additional legal action to preserve and pursue your rights.

Your information will be kept private. You can download and file a claim at www.OfficialBSAclaims. com or call 1-866-907-2721 for help on how to file a claim by mail. Scouting participants who were at least 18 years of age at the time the sexual abuse began may also have claims related to sexual abuse and should consult the appropriate claim form at www.OfficialBSAclaims.com.

If your claim is approved, you may receive compensation from the bankruptcy.

If a plan to reorganize BSA is approved, it could release claims you hold against certain third parties, including against BSA Local Councils and organizations that sponsored your troop or pack. Please visit the website to learn more.

In the coming months you will hear about offerings for youth as well as adults through Prince of Peace. Meanwhile, there are things you and your family can do this summer. Resources are readily available online on your schedule. Below is just a sampling:

- 1. The SE Synod of the ELCA is actively working for racial justice as shown by its new webpage at https://www.elca-ses.org/diversity-and-justice. This page includes links to the new *Children's Time* (diverse storybooks read by Bishop Strickland) as well as several recent webinars, now available as recordings including a discussion with the producer about the movie *Just Mercy* and a conversation with Rev. Robert W. Lee, antiracist activist and descendant of confederate leader Robert E. Lee about being called as a Christian to this work.
- 2. Not In Our Town Princeton
  (niotprinceton.org) makes webinar
  recordings and articles available on its
  website, including, 10 Myths About the
  Racial Wealth Gap by Dion Rabouin; Take the
  Next Step Toward Racial Justice by Susan
  Rice, former Ambassador to the UN; and
  many more. (Join their next Virtual meeting
  on Monday, August 3.)
- 3. Read, Watch, Learn, A Conversation with Ibram X. Kendi author of How to Be An Anti-Racist, and Dr. Charlene M. Dukes (very informational and much easier to understand than his book) is available for ondemand viewing until August 20 at pgcmls.info/anti-racism.
- 4. If hearing about racism and white supremacy makes you think only of extreme individuals or makes you uncomfortable, explore why it is important that these words become part of our conversations, especially with our children. Go to Dr. Nathalie Edmond's webpage at https://www.mmcounselingcenter.com/anti-racism-resources.html. Scroll down to Untold Story of Racism (about 17 minutes long including

her introduction). Author Ruth King and many speakers at recent webinars suggest White or other non-Black parents tell or adapt this story knowing that parents of Black sons have been having *The Talk that Whites never needed*. In case you're unsure what that means, here is one form of the rules they include:

- 10 Rules of Survival if Stopped by the Police (Known as *The Talk* for Black Sons)
- 1. Be polite and respectful when stopped by the police. Keep your mouth closed.
- 2. Remember that your goal is to get home safely. If you feel that your rights have been violated, you and your parents have the right to file a formal complaint with your local police jurisdiction.
- 3. Don't, under any circumstance, get into an argument with the police.
- 4. Always remember that anything you say or do can be used against you in court.
- 5. Keep your hands in plain sight and make sure the police can see your hands at all times.
- 6. Avoid physical contact with the police. No sudden movements, and keep hands out of your pockets.
- 7. Do not run, even if you are afraid of the police.
- 8. Even if you believe that you are innocent, do not resist arrest.
- 9. Don't make any statements about the incident until you are able to meet with a lawyer or public defender.
- 10. Stay calm and remain in control. Watch your words, body language and emotions.
